Acts of Chapter/Title

- 1892 Chapter 355, an act to incorporate the City of Everett.
- 1896 Chapter 366, an act to amend the Charter of the City of Everett.
- 1898 Chapter 215, an act to provide an additional outlet for the sewage of the City of Everett.
- 1898 Chapter 495, an act to authorize the Cities of Everett and Malden to make certain contracts relative to sewage disposal and water supply.
- 1902 Chapter 149, an act to authorize the Cities of Everett and Malden to make certain sewer assessments.
- 1902 Chapter 152, an act to amend the Charter of the City of Everett.
- 1910 Chapter 547, an act to provide for an outlet for the sewage of the Cities of Malden and Everett into the north metropolitan sewerage system.
- 1915 Chapter 253, an act relative to wires and electrical appliances in the City of Everett.
- 1917 Chapter 260, an act relative to primary elections in the City of Everett.
- 1918 Chapter 183, an act relative to the filling of vacancies in the board of aldermen and common council in the City of Everett.
- 1919 Chapter 237, an act to authorize the Cities of Malden, Medford and Everett to incur indebtedness in connection with the development of the Port of Boston.
- 1920 Chapter 518, an act to provide for placing the inspector of building in the City of Everett under the civil service laws.
- 1924 Chapter 456, an act to provide for surface and ground water drainage in the northeasterly part of Everett and the adjacent portions of Malden and Revere.
- 1926 Chapter 8, an act relative to the tenure of office of the city clerk and assistant city clerk of the City of Everett.
- 1927 Chapter 136, an act subjecting the office of city engineer of the City of Everett to the civil service laws.

- 1928 Chapter 349, an act providing for a two-year term of office for the mayor of the City of Everett.
- 1929 Chapter 255, an act authorizing the City of Everett to establish and maintain a public hospital and to acquire land therefore by purchase or otherwise.
- 1930 Chapter 361, an act providing for biennial municipal elections in the City of Everett.
- 1932 Chapter 92, an act subjecting the office of commissioner of soldiers' relief and state and military aid of the City of Everett to the civil service laws.
- 1933 Chapter 57, an act relative to the time for filing and contents of statements of candidates for nomination at city primary elections in the City of Everett.
- 1933 Chapter 86, an act placing the office of chief of the fire department of the City of Everett under the civil service laws.
- 1933 Chapter 135, an act relative to the date of inaugural of the city government of the City of Everett.
- 1934 Chapter 161, an act increasing the number of signatures required to nominate candidates for certain offices at city primary elections in the City of Everett.
- 1935 Chapter 64, an act relative to the time of inaugural of the city government of the City of Everett.
- 1935 Chapter 171, an act modifying certain building restrictions on certain land adjacent to the Revere Beach Parkway in the City of Everett.
- 1939 Chapter 60, an act relative to laying out, altering and discontinuing ways in the City of Everett.
- 1946 Chapter 441, an act providing for the preparation of plans and the construction of a dam on the Mystic River in the Cities of Somerville and Everett.
- 1947 Chapter 166, an act relative to the tenure of office of the city treasurer of the City of Everett. (**Repealed by an Ordinance of 9-28-92**)
- 1948 Chapter 547, an act relative to Woodlawn Cemetery.

- 1949 Chapter 259, an act relative to the holding of other offices or positions by members of the city council in the City of Everett.
- 1949 Chapter 715, an act authorizing the conveyance of certain park land by the City of Everett to the Everett Housing Authority for veterans housing purposes.
- 1951 Chapter 487, an act providing for the acquisition by the trustees of the soldiers home in Massachusetts of additional land for grave purposes at Woodlawn Cemetery in the City of Everett.
- 1956 Chapter 62, an act authorizing The City of Everett to use for highway and other municipal purposes certain land now held for park purposes.
- 1957 Chapter 317, an act authorizing the City of Everett to lease a certain parcel of land to the Everett Cottage Hospital.
- 1957 Chapter 321, an act providing that members of the regular police or fire force of the City of Everett may include any prior service in said city, in computing their vacations.
- 1957 Chapter 326, an act restricting the rights of certain cities and towns to accept certain provisions of law relative to the construction of certain incinerators by the Metropolitan District Commission.
- 1958 Chapter 187, an act authorizing the City of Everett to use certain park land for public building purposes.
- 1958 Chapter 493, an act authorizing the City of Everett to convey all or a portion of Marine Corps League Park together with another parcel of land with the building thereon in said city to the Metropolitan District Commission for recreational purposes.
- 1961 Chapter 490, an act relative to the retirement of certain war veterans in the public service.
- 1962 Chapter 152, an act authorizing the City of Everett to use certain park land in said city for highway and other municipal purposes.
- 1962 Chapter 432, an act establishing a purchasing department in the City of Everett.
- 1969 Chapter 715, an act authorizing the City of Everett to enter into certain leases with the Everett Cottage Hospital.

- 1971 Chapter 310, Payment of funeral expense for police & fire in the line of duty.
- 1976 Chapter 108 an act authorizing the City of Everett to borrow money for the purpose of constructing and equipping off street parking to be used in connection with Whidden Memorial Hospital.
- 1976 Chapter 416, s2, An act authorizing cities and towns to establish recycling commission.
- 1977 Chapter 308, an act amending the charter of the City of Everett to allow the City of Everett to use the initiative petition.
- 1978 Chapter 281, an act increasing the amount of money the City of Everett may borrow for the construction of an off street parking facility.
- 1978 Chapter 576, Tax abated home improvements
- 1981 Chapter 606, An act further regulating the operation of certain premises licensed to sell alcoholic beverages.
- 1982 Chapter 73, an act establishing the Everett Development and Financial Corporation.
- 1982 Chapter 597, An act providing for the issuance without payment of a fee of distinctive license plates to former prisoners of war.
- 1982 Chapter 653, An act providing relief from the impact of revaluation.
- 1983 Chapter 324, An act further regulating the rights of certain firefighters or police officers who were laid off in 1981 and 1982.
- 1984 Chapter 473, An act to improve retirement regulations for teachers.
- 1985 Chapter 13, an act authorizing the sale of a certain parcel of park land in the City of Everett.
- 1985 Chapter 188, An act improving the public schools of the Commonwealth.
- 1986 Chapter 284, An act further regulating the installation of automatic sprinkler systems.
- 1986 Chapter 73, An act providing relief from the impact of revaluation.
- 1986 Chapter 265, An act requiring automatic sprinklers in Boarding Houses.

- 1986 Chapter 705, An act further regulating group life insurance.
- 1988 Chapter 308, an act relative to the licensing of certain pool tables in the City of Everett.
- 1988 Chapter 318, an act establishing a general liability fund in the City of Everett.
- 1989 Chapter 33, an act exempting the position of City Auditor in the City of Everett from the provisions of the Civil Service Law.
- 1989 Chapter 642, An act relative to installation of automatic sprinkler systems.
- 1990 Chapter 65, an act relative to the payment of a certain court judgment by the City of Everett.
- 1990 Chapter 133, an act establishing the Everett Economic Development and Industrial Corporation.
- 1990 Chapter 146, an act relative to the reduction of the term of office of members of the School Committee in the City of Everett.
- 1990 Chapter 254, An act further regulating service beyond the age of 70 by public employees in the Commonwealth.
- 1990 Chapter 291, an act permitting a charge for directory assistance and improving telecommunications within the Commonwealth.
- 1990 Chapter 453, an act relative to the Board of Park Commissioners of the City of Everett.
- 1991 Chapter 494, an act which requires a person, who is receiving compensation from the City for services performed and is not a member of the Contributory Retirement System under Chapter 32, to participate in a deferred compensation program.
- 1993 Chapter 481, an act relative to holders of Common Victualler Licenses that sell wines and malt beverages may, upon written approval of the License Authority, also sell liquors and cordials.
- 1994 Chapter 235, An act further regulating the rights of certain firefighters and police officers.
- 1996 Chapter 71, an act relative to authorizing certain public employees creditable retirement service for active service in the Armed Forces.

- 1997 Chapter 17, An act relative to the annual cost of living adjustments for retirees.
- 1998 Chapter 455, an act authorizing the City of Everett to issue certain pension obligation bonds.
- 1998 Chapter 456, An act relative to granting cost of living adjustments to noncontributory retirees.
- 1999 Chapter 127, use a certain parcel of playground land for the construction, maintenance and use of schools.
- 2000 Chapter 96, authorizing the MDC to dispose of a certain easement located in the city of Everett
- 2001 Chapter 115, Act providing for an executive director of city services in the city of Everett
- 2001 Chapter 211, An Act designating the conference room in the Allied Veterans Memorial Rink in Everett as the Michael V. Fonzi Memorial Room
- 2002 An Act relative to Certain School Construction Projects in the towns of Milton and Winchester and the Cities of Brockton, Everett, Revere and Waltham
- 2002 Chapter 116, s1 & s2, An act providing for local government workforce reduction through an early retirement incentive program for certain employees.
- 2002 Chapter 288, An Act establishing a 4 year term for the office of mayor in the city of Everett, ballot question.
- 2002 Chapter 309, An Act relative to the issuance of certain bonds by the city of Everett.
- 2002 Chapter 423, An Act relative to the health insurance of certain employees of the city of Everett.
- 2003 Chapter 137, An act relative to public employees serving in the armed forces of the United States.
- 2005 Chapter 157, An act relative to disability retirement benefits for veterans.
- 2006 Chapter 205, s11, An act relative to streamlining and expediting the permitting in the commonwealth.

- 2006 Chapter 260, s12, An act for Nat'l Guardsmen & Serservists that are deployed outside U.S. or their dependents up to 180 days after that service to pay their property taxes without interest or penalties.
- 2008 Chapter 24, An act authorizing the appointment of special police officers in the City of Everett.
- 2008 Chapter 155, An individual running for elective office shall have his name on the ballot only for 1 office that is 1 seat at any 1 election.
- 2008 Chapter 191, An act designating a certain traffic rotary in the City of Everett as the Edward G. Connolly Memorial Rotary.
- 2008 Chapter 486, An act relative to putting a question on the 2009 ballot "Shall the city of Everett nominate and elect a charter commission in accordance with the provisions of chapter 43B of the General Laws of Massachusetts?".
- 2010 Chapter 26, An act relative to the collection of unpaid municipal fines.
- 2010 Chapter 131, s27&28, Increase widow allowance from \$6,000 to \$9,000.
- 2010 Chapter 157, An act validating the election of a charter commission in the City of Everett.
- 2010 Chapter 188, s66, An act relative to municipal relief, early retirement.
- 2010 Chapter 188, s19, An act relative to increasing COLA base from \$360 to \$390.
